

Native American Unique GMAT Examinees

Population and Geography

Native Americans, with 750 unique GMAT examinees in TY2011, are the smallest underrepresented US population group in the business school pipeline*.

- Native Americans account for nearly five percent of the underrepresented US populations among GMAT examinees, and make up nearly one percent of all US unique GMAT examinees.
- Among Native American unique GMAT examinees, men outnumber women by 10 percent (approximately 55% men vs. 45% women).
- The representation of women Native Americans is greater, however, when compared with all other unique US GMAT examinees (non-underrepresented population), where women represent only 37 percent of GMAT examinees.
- The majority of Native American unique GMAT examinees are 30 years of age or younger (73%). Within this age range, Native Americans between the ages of 25 and 30 are the largest age cohort, and outnumber those younger than 25 (42% vs. 31%).
- By region, the West has the largest percentage of unique Native American GMAT examinees, nearly 37 percent; Other US regions with large representation of Native Americans are the Southwest (21%) and the South (14%).

*Note: Data are presented by unique GMAT examinees for Testing Year 2011, the period from July 1, 2010, to June 30, 2011. Underrepresented populations in this analysis refer to African American, American Indian, Alaska Native, Pacific Islander, and other Native American, as well as Hispanic American populations (including Mexican American, Puerto Rican, and other Hispanic American groups).

Work Experience

The vast majority of Native American unique GMAT examinees have some work experience (85%), and the most often reported level of work experience was between four and nine years in TY2010.

Native Americans have a similar percentage of unique GMAT examinees with no work experience—nearly 15% reported zero years—when compared with other underrepresented US population groups, about 15 percent for African Americans and Hispanics. This is less than the percentage of all other unique US GMAT examinees (non-underrepresented population) with no work experience, at 21 percent.

Educational Attainment and Business Studies

Business and Commerce is the MOST cited undergraduate major among Native American unique GMAT examinees (56.8%), consistent among all GMAT examinees from the United States.

- The fields of Social Sciences and Science and Engineering are the second- and third-most-reported undergraduate major by Native American unique GMAT examinees (17.8% and 15.2%, respectively).
- The representation of current undergraduates among Native American unique GMAT examinees is nearly 16 percent, slightly less than the 19 percent of all other unique US GMAT examinees (non-underrepresented populations) that indicated they had not yet completed undergraduate studies.
- The majority of Native American unique GMAT examinees report a GPA of between 3.0 and 3.5 (51.5%). In addition, 23 percent of Native American unique GMAT examinees reported GPAs of 3.6 or higher, the highest figure among all underrepresented population groups, although slightly below the 30 percent of all other unique US GMAT examinees (non-underrepresented populations).
- Twenty percent of Native American unique GMAT examinees scored 600 or higher on the GMAT exam in TY2011, a
 greater percentage when compared with the 11 percent of African Americans and 19 percent of Hispanics in that
 score range.
- Nearly 72 percent of Native American unique GMAT examinees indicate their intention to pursue a Master of Business Administration (MBA). This proportion is consistent with that of all other groups: 69 percent for Hispanics, 71 percent for African Americans, and 70 percent for all other unique US GMAT examinees (non-underrepresented populations).
