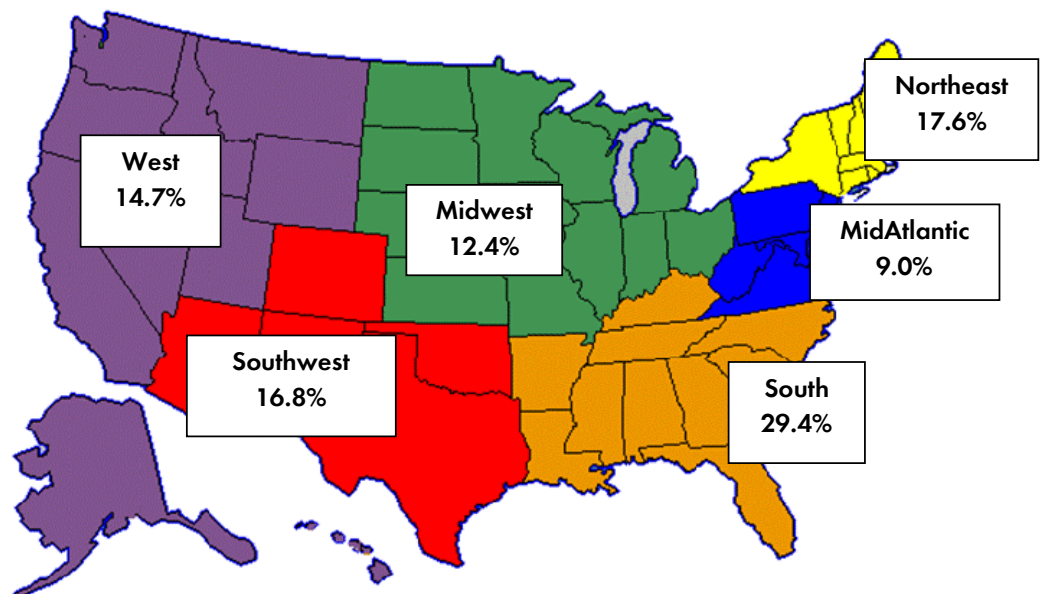

## Underrepresented Populations Unique GMAT Examinees

### Population and Geography

Underrepresented populations (URPs), with 16,417 unique GMAT examinees in TY2010, account for 15 percent of the US graduate management education pipeline\*.

- Of unique GMAT examinees from underrepresented population groups, there is a small gender gap where men narrowly outnumber women (51% men vs. 49% women).
- The representation of women URPs is greater when compared with all other unique US GMAT examinees (non-underrepresented population) with only 38 percent women examinees.
- The majority of URP unique GMAT examinees are 30 years old or younger (74%). Within this age range, URPs between the age of 25 and 30 slightly outnumber those younger than 25 (41% vs. 33%).
- By region, the South has the largest percentage of unique URP GMAT examinees, just over 29 percent; other US regions with large representation of URPs are the Northeast (17.6%), the Southwest (16.8%), and West (14.7%). The regional representation is different from all other unique US GMAT examinees (non-underrepresented population) where the South ranks second behind the Midwest.

## Work Experience

The majority of Underrepresented Populations unique GMAT examinees have some work experience (86%), and the most frequent reported level of work experience was between four and nine years (33%) in TY2010.

- URPs have a lower representation of unique GMAT examinees with no work experience (14.3% reported zero years) when compared with all other unique US GMAT examinees (non-underrepresented population), at nearly 21 percent.
- Additionally, the number of URPs with between four and nine years of work experience (33.3%) is greater than that of all other unique US GMAT examinees (non-underrepresented populations), at 31 percent. Also, URPs have a greater distribution of work experience ranging from four to nine years, 10 to 14 years, and 15-plus years.

## Educational Attainment and Business Studies

**Business and Commerce is the MOST common undergraduate major among Underrepresented Populations unique GMAT examinees (60.3%), which is consistent among all other US GMAT examinees.**

- The fields of Social Sciences and Science are the second-most-reported undergraduate major by URP unique GMAT examinees, with just over 13 percent in each field.
- The representation of current undergraduates among URP unique GMAT examinees is nearly 14 percent, slightly below the 20 percent of other unique US GMAT examinees (non-underrepresented populations).
- The majority of URP unique GMAT examinees report a GPA of between 3.0 and 3.5 (51.3%).
- Sixteen percent of URP unique GMAT examinees reported GPAs of 3.6 or higher, which is below the 29 percent of all other unique US GMAT examinees (non-underrepresented populations).
- Fourteen percent of URP unique GMAT examinees scored 600 or higher on the GMAT exam in TY2010, which is below the 37 percent of all other unique US GMAT examinee (non-underrepresented populations).
- Nearly 73 percent of all URP unique GMAT examinees intend to pursue an MBA or Master of Business Administration. This is on par with all other unique US GMAT examinees (non-underrepresented populations); 72 percent of which reported the same intentions.
- Fifty-nine percent of URP unique GMAT examinees intend to study full-time, slightly more than all other unique US GMAT examinees (non-underrepresented populations), at 56 percent.

Demographic data for the 16,417 unique GMAT examinees in TY2010 who identified themselves as underrepresented populations are presented below. Examinees are not required to provide biographical and demographic information. *Bold italics* indicate the largest group within each data point.
